

## Privacy Notice of The Jussi Capital Website

Jussi Capital is committed to protecting your privacy and personal information. Jussi Capital handles personal information in accordance with the Personal Data Act (523/1999) and other applicable regulations.

This privacy policy document for the website of Jussi Capital Oy provides information about how Jussi Capital Oy and its employees handle personal information related to this Website and Jussi Capital's other online services. ### Handling of personal information

Jussi Capital doesn't collect or store your personal information in any part of its Website.

### Cookies

Jussi Capital Website uses cookies to store statistics about users of the Website and how the Website is being used.

A cookie is a small text file that is sent to and stored on the user's computer. Cookies do not harm the user's computer or files. Cookies provide Jussi Capital with information about how and when you have used the Website and help us develop the Website to offer better services. The user can choose to disable the use of cookies in the browser settings. If cookies are disabled, some functions may be slowed down and access to certain parts of the Website may be completely blocked.

Jussi Capital Website uses visitor tracking services such as the Google Analytics service to collect anonymous statistics about the users of the Website in order to improve the contents of the site. The Google Analytics service stores the following information to our use:

- the number of users on our Website daily
- user's geographic location
- which pages have been browsed
- where visitors navigated to the site
- which devices have been used for browsing the Website (computer, smartphone, tablet)
- relative share of new and returning users

Through Google Analytics service, Jussi Capital doesn't collect or store any information on the basis of which users of the website could be recognized or identified.
